1. Welcome and Election of moderator, minute taker, and vote counters

Cyndi and Martin welcomed everyone to the general assembly and agreed that the meeting will be held in English.

2. Annual report

Gardens: The previous year is summarized with some pictures from the gardens, while everybody is reminded of the general association and garden rules. 27 new gardeners are joining the association this year. The waiting list is open again until the limit is reached or 1 May. One of the big efforts this past year was to develop some of our common gardens as Permaculture beds to help educate gardeners on this low work, yet effective gardening strategy.

Garden Days: These somewhat monthly events help us to maintain the common areas and build community. We work for part of the time and do social things afterward. Everyone is expected to come on time and stay for the duration. Every member should join at least 2 garden days/year, otherwise they will be charged the absence fee. In 2024, 38 gardeners didn't come to any, 25 only for one, and 92 came for 2 garden days or more. This is an improvement over previous years. It is possible to obtain garden day credits by doing tasks advertised by the board (e.g., helping with the general assembly). Please contact the board if you have any suggestions for something that needs doing, and you can get a credit on completion of the task. In the summer, the board sends an email with the garden day credits to confirm and as a reminder to participate in the garden days. The dates for the garden days in 2025 will be selected by the incoming board at their first meeting. There is usually a garden day in April.

Harvest Festival: the harvest festival was held in September. After some work in the common areas, we enjoyed a larger meal together, featuring produce

from our gardens and common areas. The photos from the photo contest 2024 were also judged while we enjoyed looking back upon the year.

Greenhouse: Gardeners are encouraged to use the greenhouse to harden off seedlings that they have started at home, but be mindful of leaving room for other gardeners. Plants remaining without clear signage will be planted in common areas on the second garden day. The beds are for common plants and used during the garden day, so ask the board if you want to plant something. There is a special group to water the common plants in the greenhouse.

Other Events: We had the pleasure of hosting Lene Skrumsager Møller who spoke to us about her book <u>Fra Græsplæne til Grøntsagsmark.</u> Many were in attendance, and she gave us a copy of her book to add to our small library which is stored in the board container and is accessible on garden days. We also had a somewhat impromptu grillaften where gardeners brought food to throw on the grill and share with others. You are encouraged to use the Facebook group to organize such events and possibly use the dishes, etc. in the board container.

Kommune Coordination / On-site Water Efforts: Mette has worked tirelessly toward the dream of having a water hook up that will solve a lot of our problems. She has reached out many times to various actors that could have an influence on the situation. Our predicament was even featured in an article in the Bispebjerg Bydelsavisen. This has led to a recent meeting with the kommune and a bit of direction for the next step forward. There is still a lot of uncertainty, but persistent efforts are being made, and the dream is still alive.

Building madness: the board has been very lenient in the past few years about building on the individual plots. This has gotten completely out of hand and needs to be addressed. As we look at the house rules later in the meeting, we will be altering the language to officially allow for small, low built structures, i.e. cold frames and raised beds. Greenhouses and other structures with solid materials, i.e. wood or plastic sheeting must be removed as soon as possible if they are over 1 meter tall or impeding on a neighbor's light, etc. The rules also state that fences are not allowed between individual gardens. No one joins the board hoping to have to enforce overstepping of the rules. If your garden doesn't comply, please handle it before the board has to threaten expulsion from the organization.

Questions: There were many questions related to what is allowed to be built on the ground. There were drawings that suggested what is allowed and what isn't. The assembly were asked to hold off discussions til the walkthrough of updated house rules.
